1. Introduction

1.1 Background and Context

- Comparisons are with the last LAC Population Profile from January 2016.
- Compulsory school aged pupils only are reported on.
- The LAC cohort and placement types were provided by the Strategic Intelligence Team.
- School types and SEN information were sourced from Capita One and January 2017 School Census returns.
- The report has data on numbers of looked after children by school type, attending in city and out of city educational establishments, NCY, SEN and placement type.

1.3 Key Points

- As at the 13th March 2017, there were 735 children of compulsory school age looked after by Liverpool City Council. This is an 8% increase compared to the January 2016 when the last profile was compiled (675).
- A third of Liverpool's LAC population are placed in schools outside of the city (251 pupils, equating to 34% of the cohort). This is 1% higher than in March 2016 (220 pupils – 33%)
- More secondary aged LAC are educated in establishments outside of the city compared to primary aged LAC – 36% secondary and 32% primary.
- Over a third of compulsory school aged looked after children are in years 9, 10 and 11. There has been a significant increase in the numbers of primary aged LAC from January 2016 to March 2017 (13%). Secondary aged LAC pupils have risen by 5%.
- The gender split has widened slightly from January 2016 with 53% of the cohort being male (52% last year) and 47% female (48% last year).
- The percentage of the LAC cohort with special educational needs has fallen by 1% since January 2016 to 47%. However, this is still significantly higher than the local figure of 19%.
- 10.9% of the LAC cohort attends special schools compared to 1.8% of the Liverpool school population.

- 21% of secondary age LAC pupils are not attending mainstream schools. Of these, 32% of year 11 LAC is not in mainstream provision (27% in January 2016). 18% of year 11 LAC are in Alternative Provision
- In comparison only 8% of the primary age LAC cohort is not in mainstream provision. However, this is nearly 7 times greater than the primary age Liverpool cohort (1.2%).
- 15% of the LAC cohort is placed with parents or those with parental responsibility – this is a decrease of 2% compared to January 2016.
- However, a further 24% are placed with a relative or friend – 5% higher than last year
- 70% of the looked after children in Reception are placed with parents, those with parental responsibility or a relative or friend – an 18% rise since January 2016. This is compared to only 27% of LAC in year 11 – a 1% fall from last year.
- 50% of the cohort is placed in “Other Foster Placement” – up from 34% in January 2016

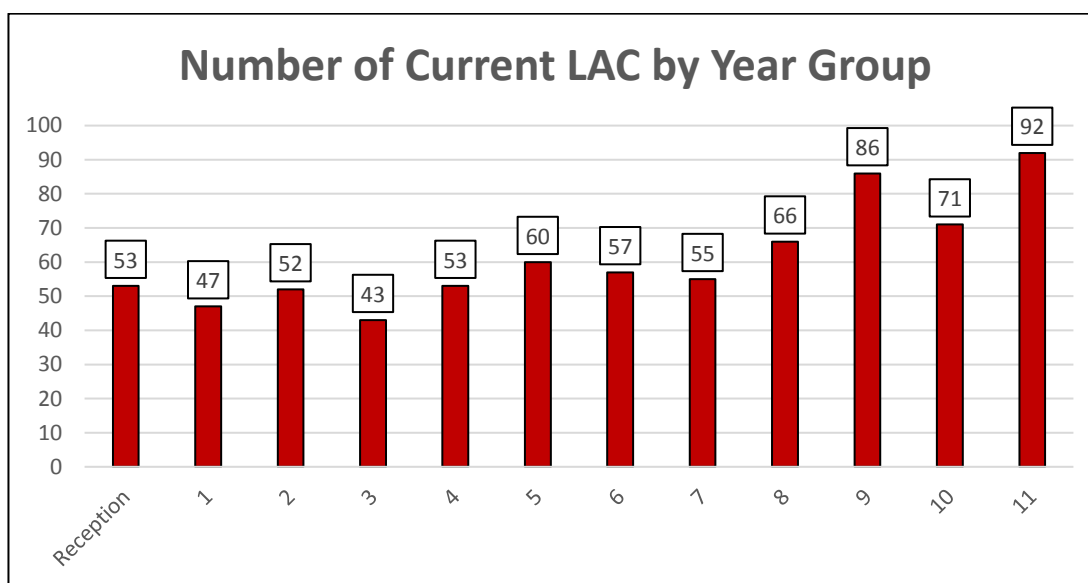

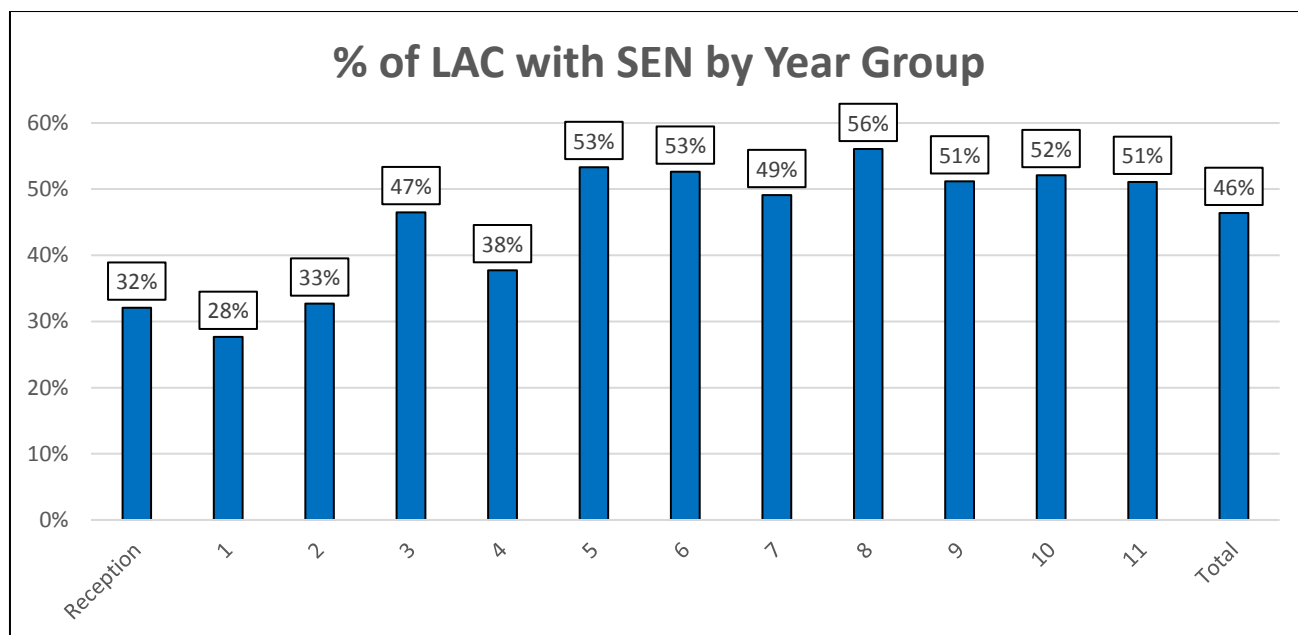
